President's Message

If you are an APS member and read the August issue of the American Philatelist, you surely noticed a strange coincidence when you came across the President's column. For those of you who did not read it, Mick Zais (who is a psychologist) entitled his column: Is There a Collector Gene? He was essentially trying to explain the same thing as I did in my last message. After listing all the possible reasons why people collect, he basically came to the same conclusion as my friend – which is that some people are simply born to collect and that there must be a gene contributing to all the possible factors in the list.

There was a time, before the internet, when the summer was a pretty quiet time for stamp collectors – but not anymore. Case in point: the Beville Collection of Classical Worldwide Stamps offered by Cherrystone auction house last July 26-27 (see page 4). I placed many bids (all well above the estimate), but they were all unsuccessful. Many lots went for 2 to 3 times the estimate. As a rule, I try to avoid bidding wars. I was luckier in another smaller but also impressive sale (only 106 lots) by H.R. Harmer on August 5 offering the Joseph Hackmey Collection of Classic BNA and US Postal History. Of special interest to me were many First Issue covers from Nova Scotia and New Brunswick including major rarities. I was able to acquire a beautiful little Nova Scotia cover franked with a pair of 1853 #1s and a first issue 1851 #4. It is the only recorded cover to the UK overpaying the official rate ($7\frac{1}{2}$ d) by $\frac{1}{2}$ penny. It was once in N. Argenti's collection – the man who wrote the book on stamps and postal history of New Brunswick and Nova Scotia. The cover has a certificate in his name. [Editor: A scan of the acquired cover is shown on page 5.]

I guess that there is no vacation possible now for the serious collector.

His professionalism and generous sharing of his knowledge and wisdom were of the highest order. Earlier this year, I sent David an email asking him if he could give me some pointers as to whether a certain copy of New Caledonia SC#1 on eBay® was genuine. Within 5 minutes he emailed me a pdf from the Serrane Guide depicting the entire 50-stamp original sheet plate!

I was shocked and saddened when he told me of his illness.

David – from one transplanted son of Michigan to another – you will be sorely missed.

Shift in Quarterly Mailing Dates for FIRST ISSUES

The quarterly mailings for the **FIRST ISSUES** Journal/Newsletter will shift by one month starting with V26N1. In other words, the normal quarterly intervals of Jan-Feb-Mar, Apr-May-Jun, Jul-Aug-Sep, and Oct-Nov-Dec will shift to Feb-Mar-Apr, May-Jun-Jul, Aug-Sep-Oct, and Nov-Dec-Jan. Everyone will still receive four issues of the Newsletter each year – in accordance with the Club Bylaws.

The "fiscal year" for the club will continue to run from January 1 through December 31. Hence, dues will still need to be paid prior to January 1^{st} of each year for members to remain in good standing.

The shift in publication dates is to better avoid the timing issues for the first edition each year. The Newsletter timing is such that it needs to be finalized one month prior to publication in order to get it printed, folded and franked for mailing. For the first edition each year, this means that these activities occur from the U.S. Thanksgiving celebration through the Christmas holidays. These are prime periods for people taking vacations from work – making publication even more hectic. The new schedule allows for the preparation leading up to mailing of the first edition to occur in January rather than December.

So, for the foreseeable future, you will be receiving your Newsletters at the beginning of February, May, August and Nov. Happy reading!

On-line/Virtual Bidding in Philatelic Auctions – The Beville Collection

Nearly every major philatelic auction house now streams their auctions "live" on the internet. They have done this to increase bidding – and it works nicely. For years, bidding in these auctions was accomplished by: (a) attending in person (i.e., floor bidders), (b) submitting bids by mail or internet to the auction house before the auction starts, (c) hire an agent to bid for you (for a 5% fee), or (d) bidding live by phone. Add to those options, (e) internet bidders submitting live interactive bids via the computer while the auction is in progress. I have to admit, I am now a fan of the last method.

When I receive an auction catalogue in the mail, my usual practice is to scan the listings and jot down the 4-8 lots that captured my attention. After studying the descriptions in depth, I decide on the few I might want to bid on. If there are only lots "that would be nice to have if the price is right", I simply submit my written (maximum) bids to the auction house and wait to see if I am outbid on them. If there are one or two lots I "really want", then I might set aside the time to sit in front of the computer and bid on those interactively.

Last June, I received an auction catalogue from Cherrystone Philatelics entitled the BEVILLE COLLECTION: STAMPS OF THE WORLD 1840-1940. This auction appeared to be the disposition of a single philatelist's collection. The listings were highly impressive – and the dream of "first issues" collectors like FICC members. Among the 1270 lots, over 30 contained a #1 by itself. Another 30+ lots had complete or partial "first issue" sets, and many more lots contained complete/partial countries containing the first issues. Further, there were 20+ lots of scarce BOB#1s and another 30-40 lots of stamps from the "first issue sets" that did not include #1s. I felt like Willie Wonka in the Chocolate Factory.

For the BEVILLE COLLECTION, my initial review netted over 80 lots that caught my interest. So, what did I do with this excess of desires? This list was "reduced" to 58 lots after studying the descriptions. My only thought was, "Wow!!!" Adding up just the minimum bids, the sum exceeded my stamp budget for the next 4+ years.

From there, I prioritized the list into 3 categories: "A" – rarities or stamps I could not remember seeing for auction in the last 10 years; "B" – (my "toughie" list) stamps I had been actively seeking at stamp shows or in auctions for quite some time – without luck; and "C" – all the remaining lots. I had 9 As, 22 Bs and 27 Cs. Although I wanted the "A"s badly, I figured they were out of my price range. So I settled on a list of 9 "B" lots and set upper bid limits on those to maintain my budget (or not exceed it too badly). Further, I developed a supplemental list of "B" lots that I would use as substitutes if I was outbid on lots in my original list.

This strategy required I log into the auction web site and sit in front of my computer just the same as if I was attending the auction in person. And the experience, while time consuming, was fascinating and something I would do again.

On the auction days, I got a cup of coffee, a book to read and got comfortable in front of my computer to watch the action. I noted the hammer prices on the lots among the "58 chosen" and bid only on those lots I had pre-selected. All too often, the auctioneer had received mail bids which started the bidding above my pre-determined limit. Although unfortunate, I maintained my strategy and replaced those lots with "alternates".

Among my "A" lots were the following, with the result also given. [All dollar amounts are in US \$ and the final prices include a 15% buyer's premium.]

- Duttia Sc#1 MNGAI (only 4 recorded examples) Starting bid of \$5,000; final price of \$13,800. More than double the Scott Catalogue Value of \$6,250.
- Perak Sc#1 MNG Starting bid of \$1,000; final price of \$3,738. Well above the SCV of \$2,200.
- Guam Sc#9 MHR (a stamp I need to complete my #1-12 set) Starting bid of \$1,000; final price of \$2,875. Above the SCV of \$2,750.
- Puerto Rico Sc#200 MNG (only 25 recorded examples per the description) Starting bid of \$2,500; final price of \$8,625. Above the SCV of \$7,500.
- Syria Sc#1-10 MNH (only priced as hinged in Scott) Starting bid of \$750; final price of \$1,840. An excellent buy as the hinged SCV is \$1,528.

There were some bargains among the "high SCV" stamps also. These, however, mostly had faults noted on the certs.

- Switzerland Sc#4 used with small faults Starting bid of \$2,500; final price of \$5,750. Only 21% of the SCV of \$27,000.
- French Sudan Sc#2 used with faults Starting bid of \$475; final price of \$719. Less than 15% of the SCV of \$5,000.
- Azores Sc#1 used with no faults noted Starting bid of \$750; final price of \$863. Only 36% of the SCV of \$2,400.

So, how did I do? I was outbid on several lots on of my original list, but I kept adding lots from my supplemental list and ended up winning 10 lots. And, best of all, I stayed under my budget and never exceeded my pre-established limits. A pat on my own back for my self-discipline. By maintaining prudence, I never paid more than 55% of SCV for any individual lot.

WEB SITE TRAFFIC: The number of visitors to the web site doubled for the period mid-June to late July and I thought SEO (Search Engine Optimization) measures were taking effect. But they dropped down again after that to an average of around 10 per day. So the surge remains unexplained. In the last three months, we had 400 individual visitors bringing the total of countries to 68, the most recent additions being Pakistan, Nigeria, South Africa and Nepal.

WEB SITE CATALOGUE PROGRESS: The remaining detail pages to the end of the FICC Catalogue were completed in July and August. This was much earlier than the target of the end of the year and attributable to some hard work and the earlier geographic approach: all the European pages were written in 2016 and the most first issues since 1990 have been from Europe.

Yemen First Issue Variety – Genuine or Fake?

First Issue collectors are likely to be familiar with the 1926 issue of Yemen, the "jambiya" or crossed dagger stamps (Scott #1-3). These stamps were described in the *First Issues* article "The First Issues of Yemen (Yemen Decoded)" by Tim Balm (V9-N1, Jan-Feb-Mar 2001).

The illustration shows a copy of Yemen Sc#3, the 5 bogash value, <u>with</u> <u>yellow colored wash applied</u>. Scott, Gibbons and Michel list only the 2-1/2 bogash low value as existing with added colored wash (Sc#2).

Well known philatelic writer Bruce Conde reported seeing three copies of Sc#3 with orange wash in a collector's album in Beirut in 1950. He described them as being the wove paper variety, on piece on non-philatelic mail with 1930 postmarks. 1930 was the last year of postal use for the "jambiya" stamps which led Conde to conclude that either a decision was made at that time to color the 5b high value or that the stamps were painted by accident.

The illustrated stamp is on the more commonly seen horizontal laid paper. The partial seal cancel is the first Sana'a 28mm diameter type which had the Islamic year date 1344, corresponding to Western year 1926. The stamp matches position 11 from the sheet of 20 and appears to be genuine, but is the color wash also genuine or is it a fake production?
